CONDITIONS OF ISSUE

- 1. This identity card is an official document and is issued subject to the conditions hereon and to the penalties and provisions of Section I of the Official Secrets Act 1920, and of the Defence Regulations. Its alteration, defacement, irregular use, transfer to another person, impersonation of the authorised holder, loss by neglect, destruction or unauthorised retention, are penal offences.
- 2. This card relates only to the identity of the person described. It is not available as a passport, pass or permit, except as officially authorised by the Air Ministry, Provost Marshal, R.A.F.




