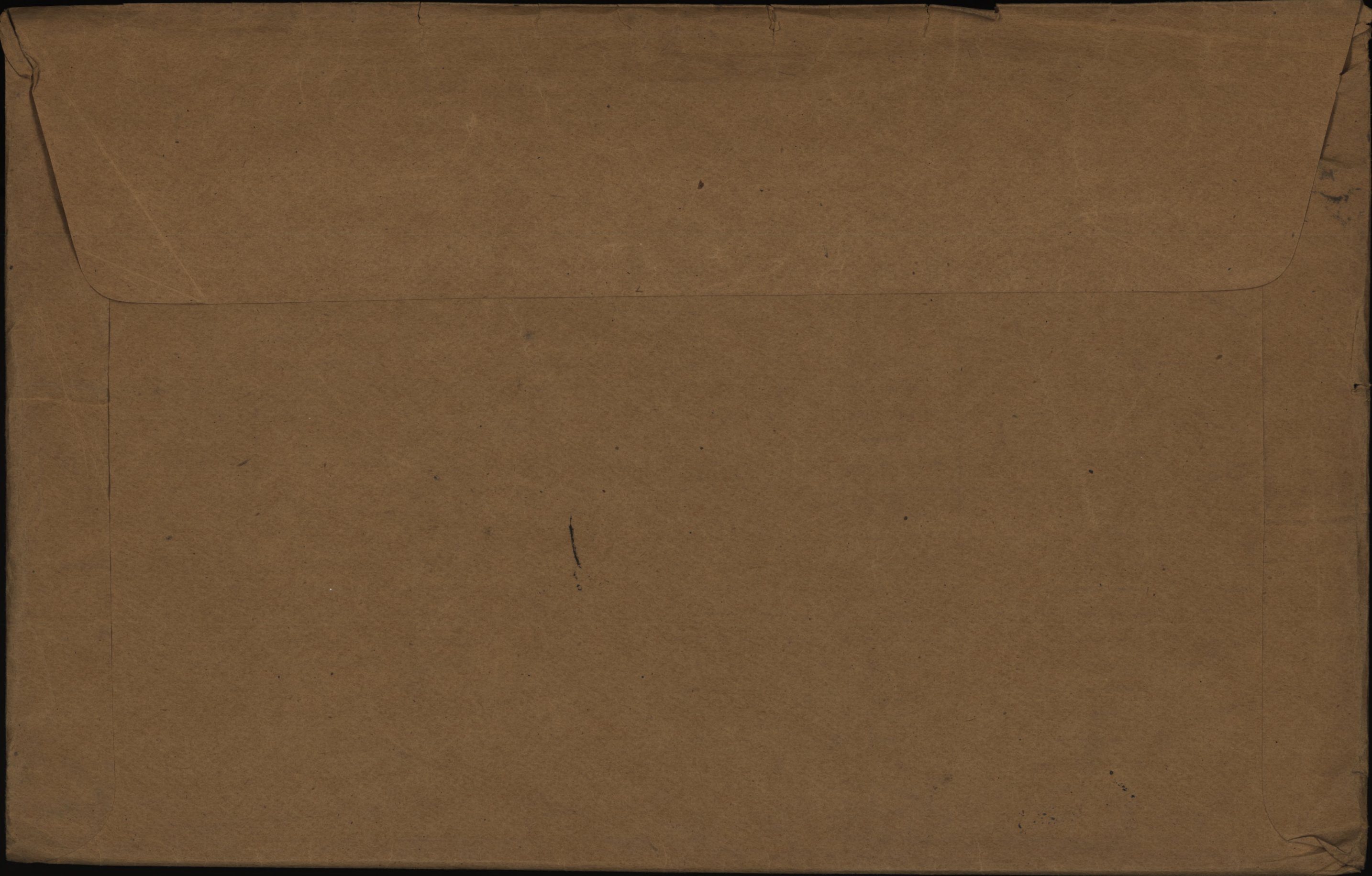

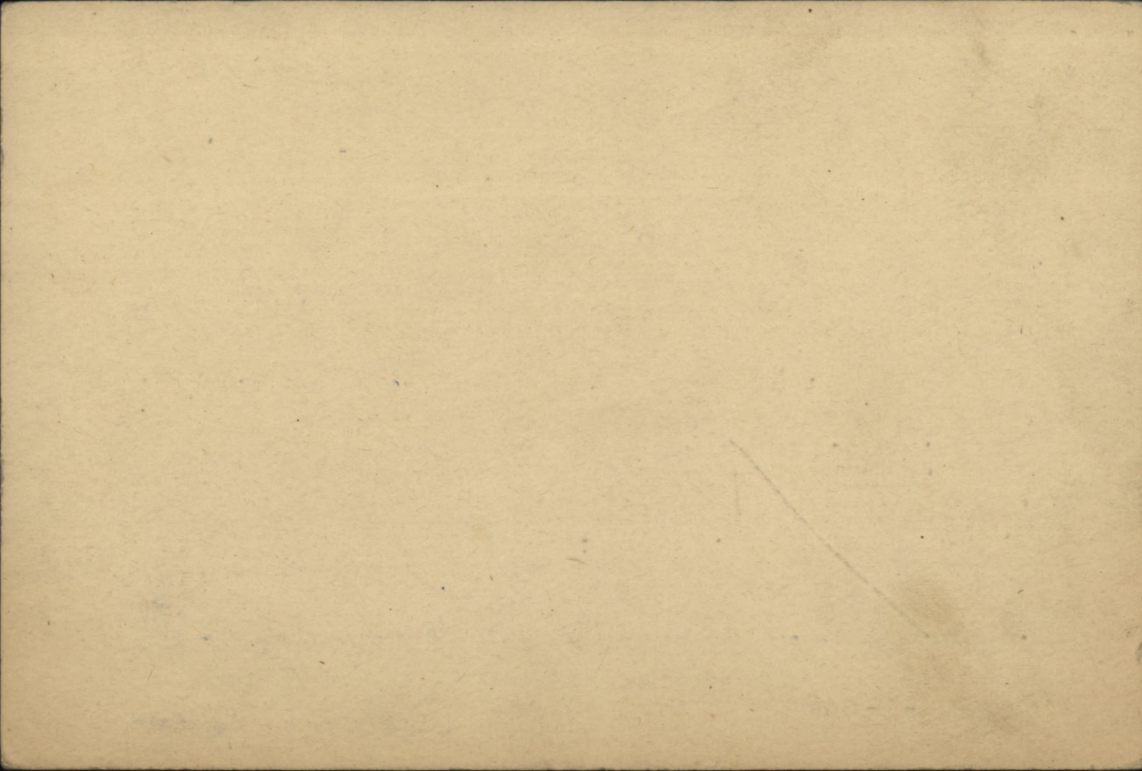

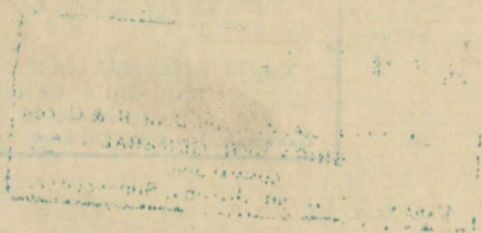

Was injured by pressure of knee of another man against his abdomen while off duty in Neuse Enghien, ^{about Apr. 20th 1915} but was with fatigue party behind the trenches. It was ordinary food natured scuffling. About 3 hours after being hurt began to feel sick at the stomach. Was sent to Beauval Hospital for 7 days then to Etappes. St John's Ambulance Brigade Hospital admitted Nov. 28th and discharged a month later Dymkhouse Folkestone, being sent to Monks Horton 3 days later. Had some pain and soreness in right side. There was some abdominal tumor shown by X Ray. Urine report - Nov. 30th a trace of albumen and very few pus cells. Was complaining much of nausea. While in France ran considerable temperature.

Present condition. Somewhat anæmic but otherwise general health and appearance is good. No pain. Somewhat short of breath in walking uphill. Heart murmur probably functional or anæmic.

History of Present Illness: The patient is a 45-year-old male who has been experiencing a persistent cough with sputum production for the past 3 weeks. The cough is worse in the morning and at night. He has also noticed a weight loss of approximately 10 pounds over the last 2 months. There is no hemoptysis, chest pain, or shortness of breath. He has a long history of smoking (20 pack-years) and has quit 10 years ago. He has no other significant medical history and is on no medications.

Physical Examination: On admission, the patient appears well but is thin. The vital signs are stable. The lungs are clear to auscultation and percussion. The heart is normal in size and rhythm. The abdomen is soft and non-tender. The rest of the physical examination is within normal limits.

Laboratory and Imaging Studies: A chest X-ray shows a small, well-circumscribed nodule in the upper lobe of the right lung. A CT scan of the chest confirms the presence of a 1.5 cm nodule in the apical segment of the right upper lobe. The nodule has a slightly irregular margin and contains a small central calcification. There is no lymphadenopathy or pleural effusion.

Pathology: A wedge resection of the lung nodule was performed. The pathology report shows a well-differentiated adenocarcinoma of the lung, with a lepidic growth pattern. The tumor is approximately 1.2 cm in size and is surrounded by a thin layer of fibrous tissue. There is no evidence of lymphovascular invasion or distant metastasis.

Discussion: The patient's clinical presentation, including a chronic cough, weight loss, and a peripheral lung nodule, is highly suggestive of a primary lung malignancy. The histological findings confirm the diagnosis of early-stage lung adenocarcinoma. The patient is currently being treated with a combination of chemotherapy and radiation therapy.

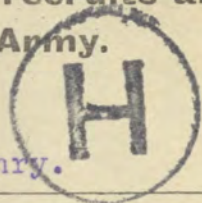
