About 2.30 P.M. 14-4-16.

While in the front line trench I noticed
something in No man's Land, and started
to get on the firing step to shoot. I put my
left foot up first, and when I started to
put my right foot up it slipped, and slat
my rifle from my left hand, when it tumbled
down I still held it with my right hand
and as it was ready to fire it is likely my right
hand touched the trigger. I did not notice at
the moment I was shot, but a moment
afterwards, saw a hole in my boot
and discovered I was wounded.
