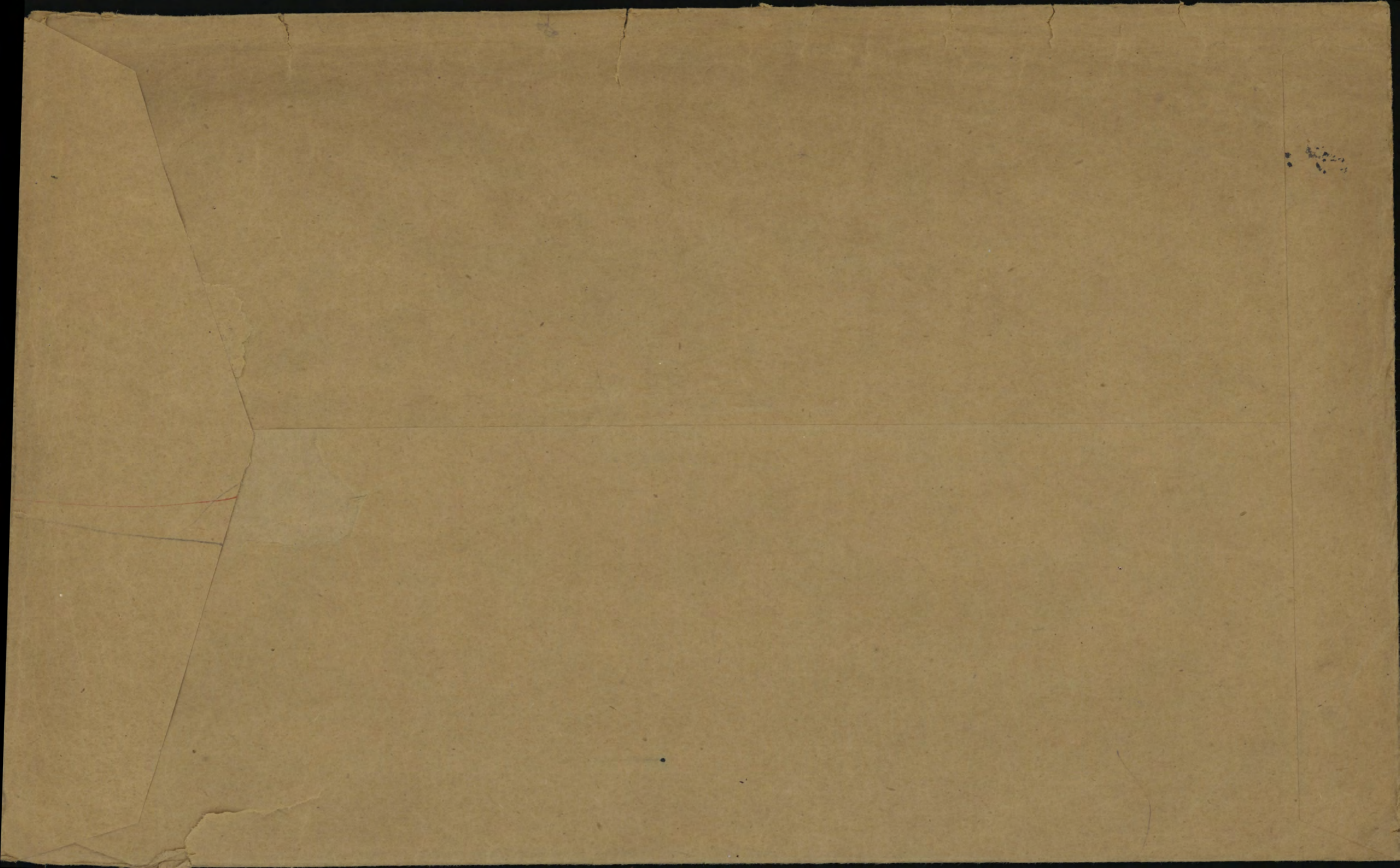

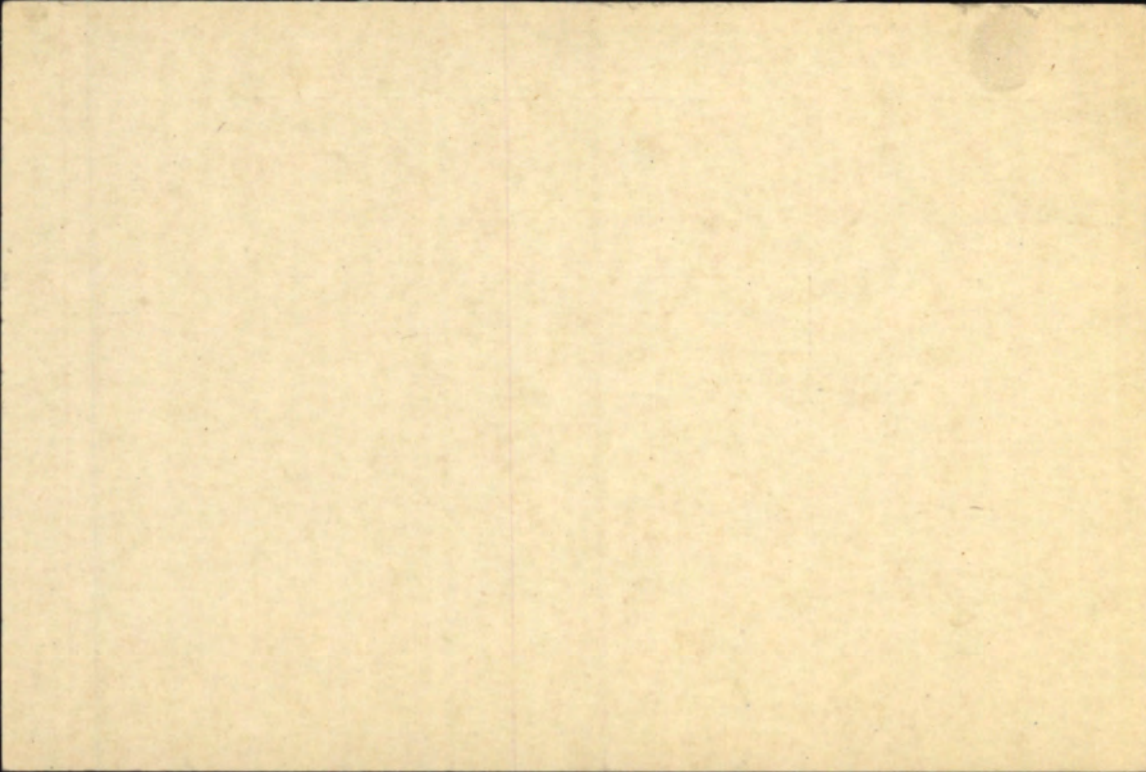

3/10/18 Seen by Major Browne. P.C. Tongue very dirty, throat fairly clean but somewhat injected. Lungs: Complains of some pain in front of chest on deep inspiration. R.D.C. in front good. Breathing somewhat harsh. Many moist râles at both bases behind. Cough somewhat troublesome during the day.

4-10-18. Pt. Temp 103°. P. 102. There is considerable cyanosis & dilating Alar Nasae. No herpes. Percussion - hyperresonant like left axilla - moist crepitations. Pat. no definite impairment resonance. Numerous moist crepitations left base. Cough.

5-10-18. Patient had poor night but rested more during day. Did not examine lungs on account of patient sleeping most of day.

Had him moved to balcony in afternoon. Notified Indelsky Officer re condition.


