Commissaire adjoint de la Police
Harlebeke

On the 22nd of February 1919 at about 16.00 hrs
a ^{off.} Boy came to the Police Station and reported
to me that a British Soldier had been
seen lying knee-deep in the water. I went
to the Town Major's office at Harlebeke and
warned the Corporal and Private there. I went
to the river with two civilians and a stretcher,
I examined the body on the spot, the soldier
was wearing two ribbons and had in his
possession a book, pipe and tobacco-pouch,
all the articles gathered and found on the
body were handed over to the Town Major's
office. I opened the tunic and shirt of the
soldier and noticed the body was quite
black and in a state of decomposition
I applied to the Town Major's office for a
blanket, wrapped up the body in it and
then conveyed it to the cemetery where the
soldier was buried. In my opinion the body must
have remained a long time, perhaps three months
in the water. The coat was
covered with mud & full of sand.
