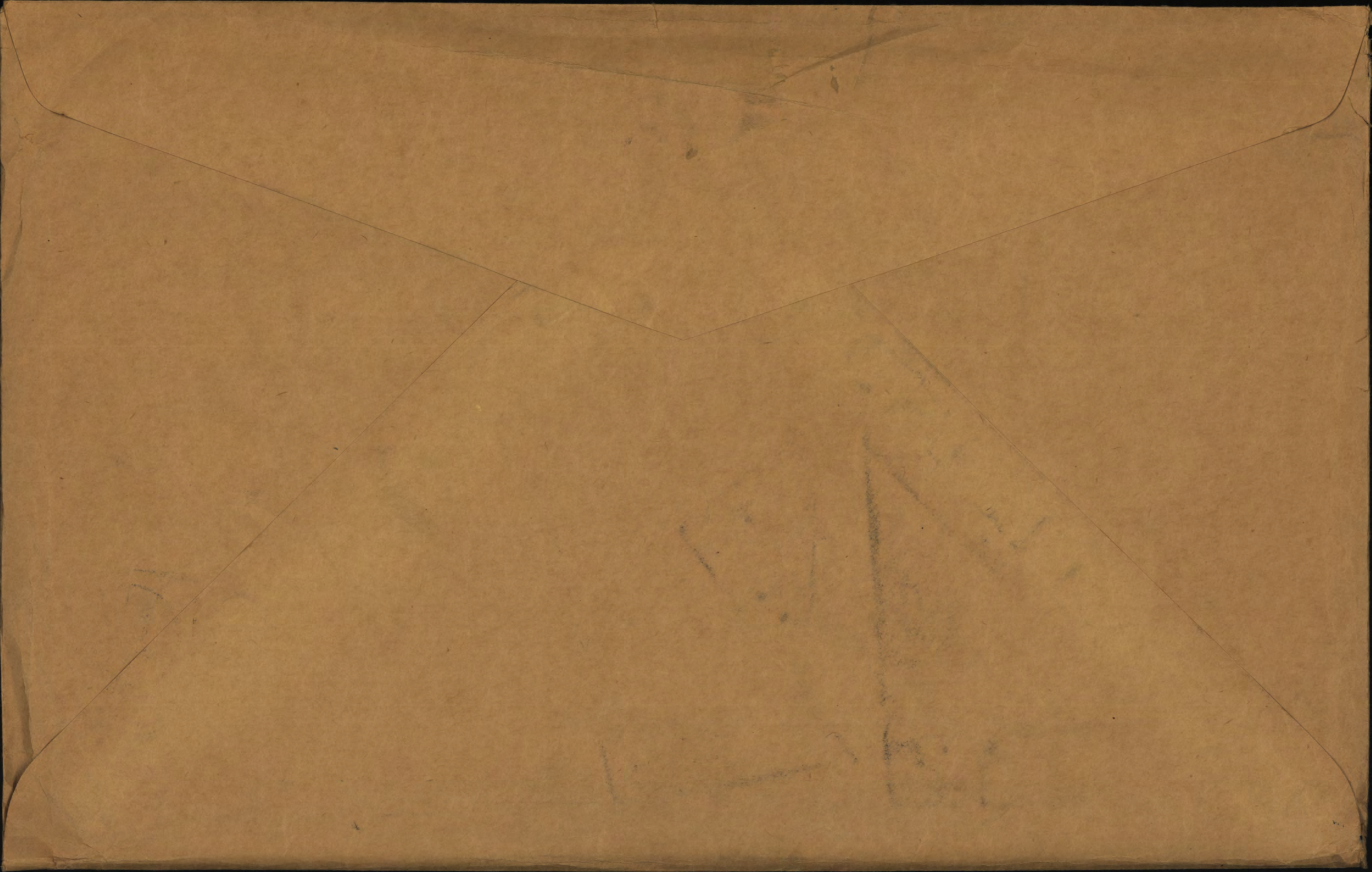

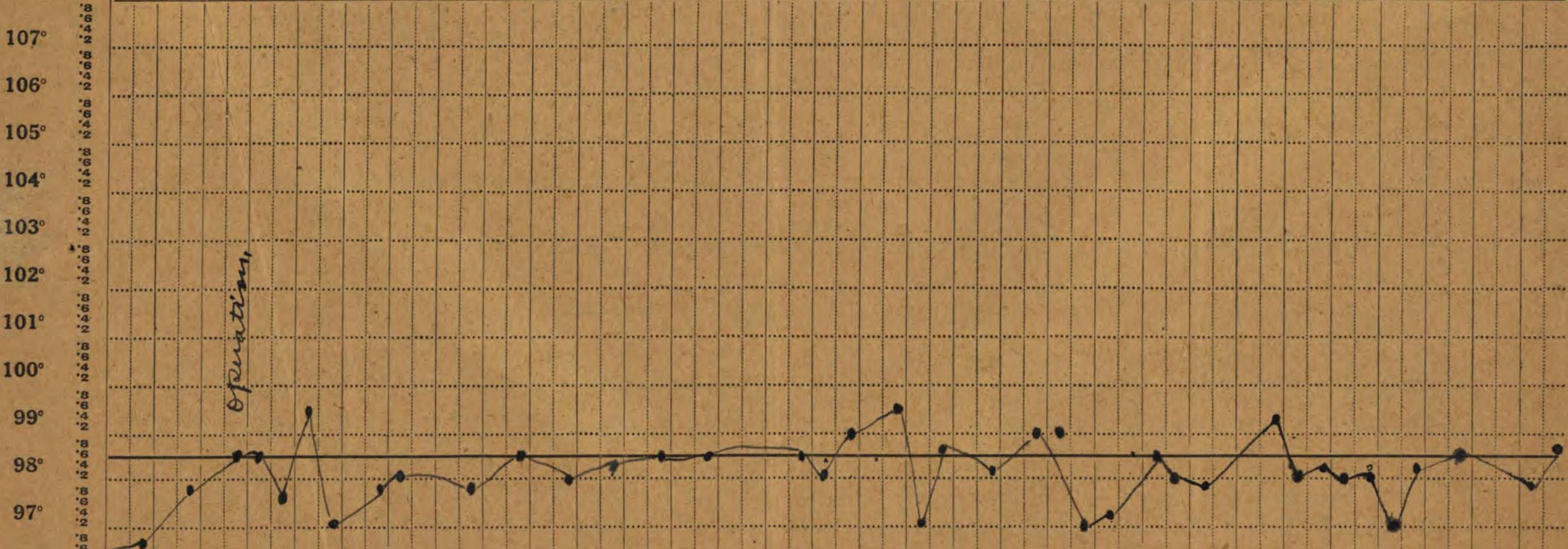

Lab. report T.B. x a. I have examined this Officer and find very slight p.s. and these scattered. Chiefly from marked auscultation lack of expansion and slight flattening I conclude the large condition is of long standing No. p.S. indication of acuteness. Mr. Hamilton has no complaints such as cough or sputum and has carried on up till onset of abscess, the results of which alone he suffers from. Recommended that treatment be carried out in Canada during sick leave (D.D.M.S. 22-4-5 - 29-11-16)

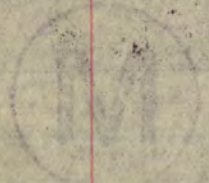
